PRIVACY POLICY

INTRODUCTION

This website privacy policy describes how we process information we collect and/or receive from you in accordance with the requirements of the Protection of Personal Information Act, 2013 ("POPIA").

1. DATA PROTECTION CONDITIONS

- 1.1 We will comply with POPIA by ensuring that the personal information we hold about you is:
 - 1.1.1 used lawfully, fairly and in a transparent way;
 - 1.1.2 collected only for valid purposes that we have clearly explained to you and not used in any way that is incompatible with those purposes;
 - 1.1.3 relevant to the purposes we have told you about and limited only to those purposes;
 - 1.1.4 accurate and kept up to date;
 - 1.1.5 kept only as long as necessary for the purposes we have told you about; and
 - 1.1.6 kept securely.

2. INFORMATION WE COLLECT AND RECEIVE

We collect and receive information about you in the following ways:

2.1 Information you give us

This includes any information that you provide to us directly:

- 2.1.1 when you sign-up to utilise our services;
- 2.1.2 by filling in forms on our websites, or those provided to you;
- 2.1.3 when you enter a competition, promotion or complete a survey;
- 2.1.4 by posting comments or content on our social media pages; or
- 2.1.5 when you contact us or we contact you and you provide information directly to us.

2.2 Information we collect or receive when you use our website or social media platforms

We collect information when you use websites or social media platforms by using cookies, web beacons and other technologies. Depending on how you access and use websites, we may receive:

- 2.2.1 Log information;

- 2.2.2 Information we infer about you based on your interaction with products and services;
- 2.2.3 Device information (for example the type of device you are using, how you access platforms, your browser or operating system and your Internet Protocol ("IP") address);
- 2.2.4 Location information.

2.3 Information from third-party sources

We may receive additional information about you that is publicly or commercially available and combine that with the information we have collected or received about you in other ways.

3. HOW WE USE THE INFORMATION WE COLLECT AND RECEIVE

We use the information we collect and receive for the following general purposes:

- 3.1 to provide you with information, products or services you request from us;
- 3.2 in order to refer you to an appropriate third-party service provider;
- 3.3 to communicate with you;
- 3.4 to provide you with support;
- 3.5 to comply with legal obligations.

4. HOW WE SHARE THE INFORMATION WE COLLECT AND RECEIVE

- 4.1 We do not sell your personal information to third parties for their marketing purposes.
- 4.2 We may share information with:
 - 4.2.1 our business partners. We may share non-personally identifiable information with select business partners;
 - 4.2.2 other parties in response to legal process or when necessary to conduct or protect our legal rights;
 - 4.2.3 companies that provide services to us. Companies that provide services to us or act on our behalf may have access to information about you. These companies are limited in their ability to use information they receive in the course of providing services to us or you; and

- 4.2.4 we may disclose your personal information to a limited number of our employees and third- party service providers (other than those who we refer you to), who we assist you to interact with.

5. YOUR RIGHTS

- 5.1 Our website uses cookies. If you wish to reject our cookies, you can configure your browser to do so.
- 5.2 We want to make sure that any personal information we hold about you is up to date. So, if you think your personal information is inaccurate, you can ask us to correct or remove it.

6. RETENTION OF PERSONAL INFORMATION

We will retain your personal information only for as long as is necessary for the purposes set out in this privacy policy or to comply with our legal obligations, resolve disputes, and enforce our legal agreements and policies.

7. OUR COMMITMENT TO SECURITY

The security of your personal information is important to us. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security. However, we do employ a number of safeguards intended to mitigate the risk of unauthorized access or disclosure of your information. We will do our best to protect your personal information and we will use up to date technology that will help us to do this. We will at all times comply with our obligation under applicable law.

8. TRANSFER OF PERSONAL INFORMATION

- 8.1 We are based in and operate from South Africa. Your information, including personal information, may be transferred to and maintained on servers located outside of your country of residence, where the data privacy laws, regulations and standards, may not be equivalent to the laws in your country of residence.
- 8.2 We might transfer your personal information to places outside of South Africa and store it there, where our suppliers might process it. If that happens, your personal information will only be transferred to and stored in country that has equivalent, or better, data protection legislation than South Africa or with a service provider which is subject to an agreement requiring it to comply with data protection requirements equivalent or better than those applicable in South Africa.

8.3 Your use of our website, followed by your submission of information to us, represents your consent to such transfer.

8.4 We will take all steps reasonably necessary to ensure that your personal information is treated securely and in accordance with this privacy policy.

9. LINKS TO OTHER WEBSITES

Our website or social media platforms may contain links to and from websites, mobile applications or services of third parties, advertisers or affiliates. Please note that we are not responsible for the privacy practices of such other parties and advise you to read the privacy statements of each website you visit which collects personal information.

10. CHANGES TO THIS PRIVACY POLICY

We may update this privacy policy from time to time. Any changes that we may make to our privacy policy will be posted on our website and will be effective from the date of posting.

11. ACCESS TO YOUR PERSONAL INFORMATION

11.1 You may, at any time, request:

11.1.1 confirmation that we hold your personal information;

11.1.2 access to your personal information;

11.1.3 the identities or categories of third parties to whom we have disclosed your personal information; or

11.1.4 that we correct or delete any personal information that is incomplete, misleading, inaccurate, excessive or out of date.
